- 3. The bidders should quote their rate per unit for each individual item above. Rates or amount for more than one item shall not be entertained
- 4. The rates quoted should be inclusive of all taxes. No additional claim above the quoted rate shall be entertained.
- Last Date for submission of quotations is 15<sup>th</sup> Dec, 2017 upto 3:00 p.m. The date of opening of envelops shall be decided at a later stage and shall be notified to the bidders accordingly. Bidder should mention his/her contract detail on the envelop.
- 6. Successful bidders should complete the work within 30 days from the date of issue of the work order.
- 7. The work is to be executed as per the description mentioned above.

8. The carpenter shall work in his own workshop and assemble and fix the final product at the new leased Building located at Rangeet Girls Hostel, 6<sup>th</sup> Mile Tadong, Sikkim University at his own cost, no additional cost for transportation shall be made.

- 11. No interest shall be paid to the contractor by the University for any deposits held by the University as security against the work.
- 12. The Registrar, Sikkim University, has the power to reject any tender or all tender or extend the date of opening of tender without citing any reasons. Decision of The Registrar, Sikkim University will be final and binding to all tenderers.
