E-Tender Notice for "Various maintenance work at the Guest House", Sikkim University

Sikkim University invites item rate e-tenders from the eligible CONTRACTOR those enlisted with Sikkim PWD/MES/CPWD or other PSU engaged with execution of civil and electrical work for the following work:

"Various maintenance work at the Guest House, Sikkim University" as per the drawing at Annexture-I and terms and conditions mentioned below:

The tentative scope of work is as stipulated in the following Bill of Quantity; however, this quantity may be considered as a rough guide pertaining to the scope of work and the bidder is expected to inspect the location of work physically before quoting the bids.

The bidder is expected to do the necessary coordination with the Engineering cell of the Univesity for actual scope of work.

The work mainly consists of Civil maintenance works such as, Aluminium partition/windows/doors repairing, plumbing fittings and fixtures replacement, wooden almirah/cupboard repairing, misc. replacements of wooden doors fittings and sanitation fittings etc.

- 2. In order to participate, the bidding firm should be registered in the online e-tender portal and should have a valid authorized Digital Signature Certificate (DSC). Bids submitted otherwise shall not be accepted.

- 4. The bids shall be uploaded in two cover system consisting of Technical and Financial bid.

 - 5.2. The financial documents required shall be as follows:
 - I. Financial Bid in prescribed format in item rate basis.

5. Bids are to be submitted through online mode at <u>http://eprocure.gov.in/eprocure/app</u>.only no hard copy is to be sent to the University.

- 6. The bidder registered with Micro and small scale enterprises (MSEs) are exempted from submitting bid security/EMD based on guide line issue by department of Micro, small and medium Enterprises. (MSME). If EMD and Application fees are claimed for exemption then the relevant MSME certificate supporting the exemption claim may be uploaded along with the online tender document with Annexure I.
- Bid Security/Earnest Money Deposit: Bidder is not required to submit any Bid Security as per the Government Office Memorandum No F.9/4/2020-PPD dated 12th November,2020. However, bidder should submit the Bid Security Declaration form on the firm's letter head.
- 8. In order to participate, the bidding firm should be registered in the online e-tender portal and should have a valid authorized Digital Signature Certificate (DSC). Bids submitted otherwise shall not be accepted.
- 9. The rate should be quoted including all costs such as labour charges/cess, headload, carriages, materials, GST, ESIC, EPF etc. No other extra charges will be entertained under any circumstances over and above the total cost quoted in the financial bid. The copy of ESIC & EPF registration valid up to the last date of bid submission may be uploaded by bidder.
- 10. The materials to be used should be of reputed make and model and duly approved by the Engineer-in-charge before execution of the same.
- 11. The work is to be executed at Guest house, Development area, Gangtok, Sikkim University, Gangtok. The bidders are advised to visit the site before bidding to access the work to be executed at site including head loads and carriages etc. No additional escalation claims by the contractor would be entertained.
- 12. Similar works executed refers to works like civil maintenance/construction works of similar nature in commercial/residential/office buildings to the tune of Rs. 3.02 lacs in last 3 (three) years.
- 13. The point of completion of work is as at Guest house, Development area, Gangtok, Sikkim University. Inspection of the completed work shall be done by Department of Engg. Cell, Sikkim University
- 14. All support related to maintenance and service should be onsite during the warranty period.

- 15. The work should be completed within 30 days of receiving of the work order failing which delay penalty will be charged @ 1% per week subject to a maximum of 10% will be charged on the total project cost.
- 16. Participating firm may contact J.E Civil Sikkim University at 9547116279 for any queries related to the tender.
- 17. a) Payment will be made after successful completion of the work. No part or advance payment shall be made.b) Performance security shall be retained @ 3% of work order value for minimum period of 180 days beyond the date of competition. Any defect in the executed work should be rectified by the contractor at his own cost during the defect liability period. The defect liability period of the work is 180 days from the date of completion of the work.c) No interest shall be paid by the University on any amount held as security.
- 18. Arbitration of all disputes related to the procurement, delivery and service of the goods would be done in the Gangtok jurisdiction, Sikkim.
- 19. Participating vendors should comply to the advertised specifications. If there is any deviation of the product being quoted from the tendered specifications then the same will be rejected during technical bid evaluation. Hence any doubt in the proposal may be clarified by contacting the number given below before submission of the online bids.
- 20. The Registrar, Sikkim University, has the power to reject any tender or all tender or extend the date of opening of tender without citing any reasons. Decision of The Registrar, Sikkim University will be final and binding to all tenderer.
