EC 41.1.1: Confirmation of the minutes of the 40th meeting of the Executive Council held on 27th May 2022

The minutes of the 40th meeting of the Executive Council held on 27th May 2022 were circulated to all the members on 6th June 2022. No comments were received from any of the members of the Executive Council.

The minutes of the 40^{th} meeting of the Executive Council held on 27^{th} May 2022 were confirmed.

EC 41.1.2: Action taken report on the minutes of the 40th meeting in the Executive Council held on 27th May 2022

SECTION-3

RATIFICATION MATTERS

EC 41.3.1: Study Leave and Cancellation of Shri Binod Bhattarai

The Executive Council noted that Shri Binod Bhattarai, Assistant Professor, Department of Sociology had requested for grant of study leave of two years w.e.f. 01.09.2022 to 31.08.2024. The Vice-Chancellor accepted the request and granted the study leave.

However, Shri Binod Bhattarai resumed duty on 30.09.2022 after availing Study Leave of 29 days w.e.f. 01.09.2022 to 29.09.2022. The Vice-Chancellor accepted his joining and his request for cancellation of the remaining period of study leave stating personal reasons.

The Executive Council ratified the action of the Vice-Chancellor for grant of study leave of 29 days w.e.f. 01.09.2022 to 29.09.2022 and cancellation of the remaining period of study leave sanctioned to Shri Binod Bhattarai.

EC 41.3.2: Application of Dr. Saurabh Maheshwari for Extra-Ordinary Leave

The Executive Council noted the request made by Dr. Saurabh Maheshwari, Assistant Professor, Department of Psychology for Extra Ordinary Leave to undertake post-doctoral Fellowship at Beijing Normal University, China w.e.f. 25.05.2022 to 31.12.2022 which the Vice-Chancellor had accepted subject to ratification by the Executive Council.

Further on his request the Vice-Chancellor accepted the postponement of starting date of Extra Ordinary Leave from 13.06.2022 to 31.12.2022 without extension.

The Executive Council ratified the action of the Vice-Chancellor of granting Extra Ordinary Leave to Dr. Saurabh Maheshwari as mentioned above.

EC 41.3.3: Release on lien and Repatriation to the University of Dr. B. Muthu Pandian

The Executive Council noted that Dr. B.Muthu Pandian, Assistant Professor, Department of Commerce was released on lien to join as Associate Professor in Central University Kerala with lien for three months w.e.f. 27.07.2022 (A/N) as accepted by the Vice-Chancellor subject to ratification by the Executive Council.

The Council also noted that Dr. B. Muthu Pandian made a request to revert back to his post of Assistant Professor in the Department of Commerce in the University within the lien period. Since the request was within the lien period the Vice-Chancellor accepted his request and Dr. B. Muthu Pandian joined the University on 20.10.2022 accepting the provision of cooling off period of two years.

The Executive Council ratified the action of the Vice-Chancellor of relieving Dr. B. Muthu Pandian on lien and accepting his reverting to the University as Assistant Professor on 20.10.2022 which was within the lien period.

EC 41.3.4: Dress Code for the 6th Convocation

The Executive Council noted the decision of the Vice-Chancellor of discontinuing the use of gowns and hoods in the ensuing 6th Convocation in pursuance to an advisory dated 15.07.2015 from UGC requesting to consider using handloom fabric for ceremonial dress prescribed for special occasions like Convocation etc.

The Notification to replace the gowns & hoods with the Khadi Uttariya (an upper garment) of different colours (specific to their programs) was also noted by the Executive Council. Further the Executive Council considered the proposal of use of separate Khadi Uttariya for the members of the Academic Procession.

The Executive Council ratified the decision of discontinuing the use of gowns and hoods in the ensuing 6th Convocation and the notified dress code as notified vide Notification No. 139/2022 dated 26.10.2022. The Executive Council also approved the proposal of the use of separate Khadi Uttariya for the members in the Academic Procession.

The Vice-Chancellor extended their contractual appointment for a period upto 31.12.2022.

The Executive Council ratified the action of the Vice-Chancellor of extending the contractual appointment of the above faculty members upto 31.12.2022 and since the recruitment would take more time the Executive Council approved extension of contract for a further period of six months w.e.f. 31.12.2022.

EC 41.4.4: Application of Ms. Swastika Pradhan for extension of Study Leave

The Executive Council noted that on its recommendation in its 40th meeting held on 27.05.2022 Ms. Swastika Pradhan, Assistant Professor, Department of Political Science was initially granted study leave for six months w.e.f. 02.05.2022 to 01.11.2022 with a clause that the approval for the next six months would depend on the progress of first six months.

Based on the six monthly progress report submitted by Ms. Swastika Pradhan and on fulfilling the eligibility under the Ordinance on study leave for extension, the Executive Council accepted her request and granted extension of study leave for a period of six months w.e.f. 02.11.2022.

EC 41.4.5: Application of Prof. V. Krishna Ananth for Sabbatical Leave

The Executive Council deliberated on the matter of Sabbatical Leave in length since this was the first Sabbatical Leave request in the University. All the members of the Executive Council unanimously felt that Sabbatical Leave application should be carefully reviewed as regards its added value or how such grant of Sabbatical Leave would be beneficial to the University / Department.

The Executive Council noted that Prof. V. Krishna Ananth is not joining any institution during the period of Sabbatical Leave and the purpose was to carry out the research work on the topic "The Constitution as an Instrument in Realising the *Idea of India* : A Historical Analysis of Legislative and Judicial Interventions (1946-2020)" as submitted by him.

One of the members of the Executive Council, Prof. Bidyut Chakrabarty pointed out and informed the Chairperson and other members of the EC that he was a referee for a research paper having the exact same title and confirmed that the work was complete or had very little scope for further work. In light of the same the Executive Council thought it was best to ask Prof. V. Krishna Ananth about his intended research work on the submitted topic and clearly justify and submit his proposal on the proposed research work. The Executive Council resolved that Prof. V. Krishna Ananth may also further elaborate if the completed work as contended by the Executive Council member is different than the same.

The Executive Council also authorised the Vice-Chancellor to go through his proposal and take a decision on the Sabbatical Leave request of Prof. V. Krishna Anath.

EC 41.4.6: Representation of Dr. Ram Bhawan Yadav, Assistant Professor, Department of English against Office Memorandum dated 01.07.2022

The Executive Council noted the facts of the case of Dr. Ram Bhawan Yadav in connection to its decision in its 39th meeting held on 23.12.2021 of imposing the following penalties:

... imposition of minor penalty under Rule 11 (iv) i.e. withholding of increments of pay for three years without cumulative effect. The same to be restored at the end of the period of three years.

Additionally, the Council also decided to impose the following penalties:

- i) Barring him from holding any administrative post or chair/member of any Committee in the University for three years.
- ii) Barring him from supervising any MPhil/PhD for 3 years including his current scholars under his supervision.

Dr. Ram Bhawan Yadav's appeal to the Council seeking permission of the Council to allow him to sign the thesis of the two scholars viz. Mr. Ghunato Neho (17PDEN01) and Mr. Ajay kumar N. (19DEN01) whose thesis are ready to be submitted as reported by him was discussed and the Executive Council resolved to appoint a Committee of Appeals to look into the appeal and forward their recommendations to the Executive Council.

The Executive Council authorized the Vice-Chancellor to appoint the Committee of Appeals to take up the appeal and report back to the Executive Council.

EC 41.4.7: Lien policy of the University

The lien policy was placed before the Executive Council and the Council noted that the revised lien policy had retained substantial part of the earlier guidelines approved by the Executive Council in its 32nd meeting including the lien period with the following additional points:

- i) The employee seeking Lien should have completed at least FIVE YEARS of regular service (including period on probation) in the University and
- ii) The number of personnel availing the lien should not **EXCEED 20%** of the total sanctioned posts in case of teaching departments and 20% of total sanctioned posts in case of non-teaching staff.

The Executive Council accepted the lien policy as submitted.

EC 41.4.8: Revision of Dress Code under the Ordinance OE-3 on Convocation

The Executive Council took note of the advisory dated 15.07.2022 from UGC requesting to consider using handloom fabric for ceremonial dress prescribed for special occasions like Convocation etc. Accordingly, the revision of dress code under Ordinance OE-3 on Convocation was discussed as placed under:

Accordingly, after thorough deliberation the Executive Council accepted the revision in OE-3 of Convocation as proposed above.

EC 41.4.9: Research Publication for Appointment and CAS of Teachers

The Executive Council discussed the UGC Public Notice No.F.1-1/2018 (Journal/CARE) dated 16.09.2019 and dated 14.06.2019 in detail.

It reviewed its decision considered in its 36th meeting held on 20.01.2021 in light of the above orders and carefully resolved as under:

- The screening of the direct recruitment is to be carried out prospectively w.e.f. 14.06.2019 i.e. Journal indexed in the UGC CARE List only to be considered for all appointments made after 14.06.2019, as the applications for direct recruitment were received on a subsequent date and the effect would also be from a prospective date.
- 2) However for CAS promotions, the date of consideration could be with retrospective effect and the UGC CARE List should be considered prospectively w.e.f. 14.06.2019. Indicating that any Research Publications published prior to 14.06.2019 may not necessarily be from the new UGC-CARE Reference List of Quality Journals (UGC CARE list) for consideration under CAS, especially when the promotion date under CAS is to be implemented retrospectively from the date of UGC Public Notice.

Care should also be taken while implementing this for CAS cases to verify whether there are any earlier cases which may get affected because of this decision and report to Executive Council accordingly.
