DEPARTMENTAL REPRESENTATIVE ELECTION 2025

This is to bring to your notice that the Departmental Representative (DR) Election for the term 2025–26 will be held on 3rd November 2025. By virtue of Article XI of the SUSA Constitution, the election shall be conducted by the Sikkim University Students' Association (SUSA) at respective departmental blocks. The dates to file the nomination by the candidates shall be from 30th October to 31st October 2025 till 4:00 PM.

From any department, if only one name is being nominated till the last date of nomination, i.e., 31st October till 4:00 PM, then he/she will be declared as uncontested, and no election shall be held. For the convenience of students, nomination forms for the Gangtok Campus shall be received and verified at the SUSA Office near the Department of Music, Cauvery Block, 5th Mile, Gangtok, and for the Yangang Campus, nominations shall be accepted and verified at Yangang Campus itself under the supervision of the appointed Election Officer. Sikkim University shall appoint one Election Officer from among the students at the university to scrutinize and conduct the election on behalf of SUSA. All students and scholars are requested to actively participate in the DR election. An attachment of the nomination form has been enclosed herewith, which is required to be filled up for nomination.

The result will be declared on 3rd November 2025, on the election day itself. We hope to see your active participation and cooperation.
