The Chairperson thanked the outgoing members, viz., Late Prof. Jyoti Prakash Tamang, Former Vice-Chancellor (Off.) and Dr. S. Murali Mohan and put on record their contributions to Sikkim University and thanked them for their support and valuable suggestions during their tenure as the Chairperson and Member of the Academic Council.

The House also observed a two-minute prayer silence to offer homage to Late Prof. Jyoti Prakash Tamang, Former Vice-Chancellor (Off.) who left for heavenly abode on 29.04.2025.

#### **SECTION-1 CONFIRMATION OF THE MINUTES & ACTION TAKEN REPORT**

##### **AC 34.1.1: Confirmation of the minutes of the 33<sup>rd</sup> meeting of the Academic Council held on 14<sup>th</sup> February 2025**

The Academic Council confirmed the minutes of 33<sup>rd</sup> meeting of the Academic Council held on 14<sup>th</sup> February 2025 as circulated to all the members on 20<sup>th</sup> March 2025.

##### **AC 34.1.2: Action Taken Report on the minutes of the 33<sup>rd</sup> meeting of the Academic Council held on 14<sup>th</sup> February 2025**

The Secretary presented the action taken report on the minutes of the 33<sup>rd</sup> meeting held on 14<sup>th</sup> February 2025. The Academic Council noted the action taken report.

## **SECTION-2 REPORTING ITEMS**

### **AC 34.2.1: Memorandum of Agreement between Sikkim University and Nagaland University**

The Council noted that Sikkim University through its Department of Horticulture and Nagaland University through its School of Agricultural Sciences entered into a Memorandum of Agreement (MoA) for academic collaboration in the fields of mutual interest between the two Universities.

## **SECTION-3 RATIFICATION MATTERS**

### **AC 34.3.1: Minutes of the meeting held on 4<sup>th</sup> April 2025 regarding Conversion Formula and Non-Coding of Answer Scripts for De-Centralized Evaluation**

The Council noted that a committee constituted to discuss on the conversion formula for obtaining percentage of marks and Coding of answer scripts for De-centralized evaluation held its meeting on 4<sup>th</sup> April 2025 and recommended the following:

#### **a) Conversion Formula for calculation of percentage of marks from CGPA**

It was observed that calculating the percentage by multiplying a candidate's CGPA (awarded on a 10-point scale as per the University Ordinance) by a factor of 10 does not accurately reflect the actual percentage of marks. This method sometimes results in a higher percentage than candidate's actual percentage for some and, while for others it yielded a lower percentage.

**Recommendation:** The aggregate percentage of marks may be calculated from the absolute marks as against conversion of CGPA to a percentage figure as follows and the conversion formula to be printed on the marks sheet for the convenience of the students.

#### **b) Non-Coding of answer scripts for De-centralized evaluation**

University Regulations on the conduct of examinations under clauses 2B(w), 5(a) and 5(d) states the following.

**Clause 2B(w):** *“For ensuring confidentiality, answer scripts of the End Semester examinations shall be coded prior to handing them over to the evaluators”*

**Clause 5 (a):** *“Evaluation of all UG answer scripts shall be centrally executed at designated location under direct supervision of the CoE or official (s) of the University / Colleges designated by the CoE”*

**Clause 5 (d):** *“..the PG answer scripts shall be evaluated by the concerned faculty at the Department”*

After deliberations, the Committee recommended for revision on the above Clauses as follows.

**Clause 5 (a) to be revised as** *“Evaluation of all UG answer scripts of the **End Semester examinations** shall be centrally evaluated at designated location under direct supervision of the Coe or official (s) of the University / Colleges designated by the CoE. **For ensuring confidentiality, the answer scripts for Central Evaluation shall be coded prior to handing them over to the evaluators.**”*

**Clause 2B(w):** It is subsumed with Clause 5(a) and may be deleted from the University Regulations on the conduct of Examinations.

The Academic Council, after deliberation, ratified the action taken by the Vice-Chancellor for approving the minutes of the meeting of the committee along with its above recommendations.

#### **AC 34.3.2: Certificate Verification Fee**

The Council noted that the Examination Department does not charge/levy any fee for the candidate/organization/Agencies asking/requesting for verifications of certificates as on date. Other Universities, including Central Universities, charge fee for verification of certificates. Hence, in order to enhance internal revenue generation, it was proposed to levy / charge fee for certificate verification request.

In line with the other Central Universities, the following fee/charge was proposed for verification of certificates.

**B. SYLLABUS MATTERS/COURSES ETC.**

**AC 34.4.B1: New Postgraduate Diploma Programme in Outcome Based Education**

The Council noted that the faculty of the Department of Education has proposed a new Post Graduate Diploma program in Outcome Based Education. Key highlights of the proposal includes the following:

The Post Graduate Diploma in Outcome Based Education (OBE) aims to develop the knowledge, understanding and skills in different aspects of outcome-based teaching and learning. The programme is

aligned with NEP 2020 and UGC's curriculum and credit frameworks. The programme will be in blended mode with both online and face to face sessions and offers a balanced mix of theory, skill-based practicum and project work. The target group of the programme will be pre-service and in-service teachers, teacher educators, curriculum developers and education professionals. The total credits of the programme is 40 and focuses on curriculum design, assessment strategies and continuous quality improvement in OBE. The programme fee is ₹8,000 (excluding admission and examination fees), with flexible scheduling to accommodate working professionals.

The School Board of Professional Studies in its meeting held on 30.06.2025 recommended the proposed new Post Graduate Diploma program in Outcome Based Education for approval of the Academic Council.

The Academic Council, after deliberations, deferred the matter on want of more details of the proposed programme in respect of financial implications against the available budget, the duration of the programme, possible collaboration with the Government of Sikkim in view of most teachers are from Government Colleges and many such other information's. The Council advised to again submit the proposal in the next meeting with all the sought information's.

#### **AC 34.4.B2: Minor changes in the courses of the Department of Mass Communication**

Based on the recommendations of the School Board of Professional Studies in its meeting held on 30.06.2025, the Academic Council approved the following minor changes in the MA Mass Communication programme:

- Introduction of Communication in Unit IV
- Communication for Social and Behavioural Changes
- Change of media terminology for Media Law and Ethics, like IPC and CRPC
- Addition of a practical component in public relations and corporate communication.

However, the Council advised that the IPC and CRPC has been replaced by Bharatiya Nyaya Sanhita (BNS), the Bharatiya Nagrik Suraksha Sanhita (BNSS), and the Bharatiya Sakshya Adhiniyam (BSA) w.e.f. 01.07.2024 by the Government of India. Accordingly, the Council suggested that the new criminal laws may be incorporated in the MA Mass Communication programme and such other syllabi of the University.



**AC 34.4.B3: FYUG (Four-Year Undergraduate) program proposed by Harkamaya College of Education**

**AC 34.4.B4: FYUG (Four-Year Undergraduate) program proposed by Loyola College of Education**

Introduction of FYUG programs proposed by the above two affiliated colleges were recommended for approval by the School Board of Professional Studies in its meeting held on 30.06.2025.

The Academic Council advised the agenda AC34.4.B3 and AC34.4.B4 to route through the College Development Council, these are college related matter and, procedurally too, it should be first placed before the College Development Council for consideration.

**AC 34.4.B5: Modification in the curriculum of MA IV Semester International Relations**

Based on the recommendations of the School Board of Social Sciences in its meeting held on 01.07.2025, the Academic Council approved the following modified curriculum structure of MA IV Semester International Relations:

1. INT-E-651: Globalisation in World Politics
2. INT-E-652: India and Its Neighbourhood
3. INT-E-653: Eastern Himalaya: Issues in Geo-Strategy and Sustainability
4. INT-O-654: State and Politics in India
5. INT-R-655: Dissertation

However, the Council advised the Department of International Relations to ensure uniform credit distribution as per NEP 2020 in the above course structure.

**AC 34.4.B6: Proposal for considering two year M.Lib.I.Sc programme as “Integrated B.Lib.I.Sc – M.Lib.I.Sc” programme**

The Academic Council noted that the Department of Library and Information Science offers a two-year (Four Semesters) Masters programme in Library and Information Science since 2022. The first batch of M.Lib.I.Sc students have graduated in 2024 and the second batch will graduate subsequently in 2025.

It has been reported that the students who were graduated in 2024 with M.Lib.I.Sc certificate were often asked to produce B.Lib.I.Sc certificate for job opportunities in various organizations/institutions and deny their entry as they failed to provide B.Lib.I.Sc certificate.

The Council also noted that the certificate issued by Sikkim University does not mention anything about the B.Lib.I.Sc in the marksheet/certificate.

According to the UGC Notification dated 5<sup>th</sup> July, 2014, the entry level requirement of the B.Lib.I.Sc and M.Lib.I.Sc programmes are as follows.

Since, the M.Lib.I.Sc programme offered by the University is of two year (4 Semesters) duration, and in order to align with the UGC notification dated 5<sup>th</sup> July, 2014, the Academic Council approved the following proposals in the larger interests of the students.

1. To use the nomenclature 'Integrated B.Lib.I.Sc – M.Lib.I.Sc' programme and to reflect the same on the marksheet and degree certificate w.e.f. 2024-25 batch.
2. To issue "Equivalence Certificate" of integrated B.Lib.I.Sc-M.Lib.I.Sc for those belonging to 2022-23 and 2023-24 batches.

**AC 34.4.B7: Approval of 1 Year NEP 2020 inspired PG Syllabus under the (4+1) Model, for the next year academic session 2026-27 of the Department of Chinese**

The Academic Council, after deliberations, deferred the PG syllabus under the (4+1) model of the Department of Chinese since the said syllabus is yet to be vetted by the NEP Committee of Sikkim University and bring in the next AC meeting.

**C. RULES AND POLICY MATTERS**

**AC 34.4.C1: Conduct of the viva-voce for MA Dissertations**

The Academic Council noted the following recommendations from the School Board of Social Sciences in its meeting held on 01.07.2025 with regard to the procedure to be followed for inviting External Experts for the viva voce examinations and subsequent amendments in the relevant Regulations:

- 1) The Departments shall submit a panel of three examiners, valid for one year before the School Board held in the month of October/ November.
- 2) Such panel will be valid for the viva voce examinations scheduled for the academic year and more specifically scheduled for May/ June of the subsequent calendar year.
- 3) The three-member panel, will have to be approved by the BoS/DC of the department concerned and shall have as panelists only from regular teachers in Universities from outside Sikkim. The Departments may elect regular teachers, including Assistant Professors from colleges/Universities outside Sikkim.

- 4) The panel, thus approved by the School Board shall be submitted to the Vice Chancellor who shall identify any one of the three as expert for the relevant academic year and convey the same to the Controller of Examination.
- 5) The Controller of Examination shall establish contact with the expert selected by the appropriate authority at the time of the viva voce examination and arrange her/his presence for the viva voce examination on the appointed date.
- 6) The viva voce examination shall ordinarily be held in the physical mode and shall be conducted over a period of at least two working days. The same may be increased depending upon the number of MA Dissertations to be examined in consultation with the Department concerned.
- 7) The CoE may suggest holding the viva voce examination in virtual mode only in the event of an emergency or contingent situations arising out of weather and road conditions with the concurrence of the department concerned.

The Academic Council, after deliberations, decided to constitute a committee under the Chairmanship of the Controller of Examinations to examine the above proposal and to bring amendments in the relevant Regulations, if found feasible.

#### **AC 34.4.C2: Revision of Ordinance OC-4 and OC-5 in line with NEP 2020**

The Academic Council, after deliberations, deferred the matter and advised the committee to relook and incorporate the suggestions/comments of the members on the revision of Ordinance OC-4 and OC-5 in line with NEP 2020. The revised Ordinances may again be placed in the next meeting of the Academic Council.

### **D. MISCELLANEOUS MATTERS**

#### **AC 34.4.D1: Increase of PhD thesis evaluation fee to ₹5000/- (Five thousand) from existing ₹3000 (Three Thousand)**

The Council noted that the Deans' Committee in its meeting held on 16.06.2025 recommended the proposal for increasing the honorarium paid to the examiners of Ph.D thesis to ₹5000/- instead of the existing ₹3000/- since many times the external examiners are reluctant to examine the PhD thesis because of less fee.

The Academic Council, after deliberations, approved the proposal for increasing the honorarium paid to the examiners of Ph.D thesis to ₹5000/-. The Council also advised that this honorarium/evaluation fee of PhD thesis should be included in the admission fee.

#### **AC 34.4.D2: Memorandum of Understanding between Sikkim University and Rajiv Gandhi University**

The Council noted the proposal for entering into Memorandum of Understanding (MoU) between Sikkim University and Rajiv Gandhi University for academic collaboration in the fields of mutual interest between the two Institutions as submitted by the Chairperson, NEPCSU. The purpose of the MoU, but not limited to, is to make collective efforts by both Universities to implement the vision set forth by the National Education Policy (NEP) 2020. The Council also noted the following objectives and scope of the proposed MoU:

##### **1. Objective**

- 1.1. To establish a legal framework for cooperation between SU and RGU for the implementation of NEP 2020 and other academic initiatives.
- 1.2. Subject to their respective rules, regulations, statutes, ordinances, and applicable laws, the Parties shall endeavour to promote and enhance mutual cooperation in areas of academic and research interest.
- 1.3. The Parties agree to share infrastructure, knowledge, and human resources to facilitate the implementation of the NEP 2020 in letter and spirit.

##### **2. Scope:** The collaboration shall include, but not be limited to:

- 2.1. Implementation of the Multiple Entry and Exit framework under NEP 2020.
- 2.2. Mutual recognition and transfer of academic credits.
- 2.3. Joint academic and research programmes and projects.
- 2.4. Capacity building of students and faculty.
- 2.5. Exchange of faculty, researchers, and students.
- 2.6. Joint seminars, conferences, training programmes, and outreach initiatives.
- 2.7. Joint publication and policy formulation.
- 2.8. Launch of new academic programmes and courses.
- 2.9. Mobilisation of funds for collaborative projects.
- 2.10. Any other activity mutually agreed upon in writing

The Academic Council, after deliberations, recommended the proposed MoU between Sikkim University and Rajiv Gandhi University for approval of the Executive Council.

  - b) To write a strong letter asking as to why Principal, NBBGC, Tadong did not comply with the university letter dated 18.10.2024 for applying for affiliation of eight PG subjects offered at the college and also to request him to apply for affiliation of PG subjects immediately in prescribed format.

- c) Holding of Affiliation Order of those colleges which have yet to deposit affiliation fee for the academic session 2025-26 and to send a list of colleges which have not submitted affiliation fee to the Director, Education Department, GoS for payment.
- d) Himalayan Pharmacy Institute (HPI), Majhitar to seek accreditation of the institute at the earliest.
- iii) Revisiting examinations and registration fee for students of affiliated colleges as recommended below:
  - a) To enhance the fee for theory and practical with 2% non-cumulative enhancement annually as per OC-3 retrospectively from 2016 for both UG General and UG professional as follows;

- b) Now onward, 2% non-cumulative enhancement will be levied on the examination fee every year as per OC-3 of the University Ordinance and a notification to this extent will be issued every year.
