7.02.1 The House noted with deep sense of grief the passing away of the eminent personalities mentioned above. As a mark of respect of departed souls the House observed two minutes silence.

AC:07:03 Performance Highlights by the Vice-Chancellor

Minutes:

7.03.1 The Vice-Chancellor made a power point presentation highlighting the various activities of the University since the last meeting of the Academic Council held on 2.06.2010 [Annexure AC VII - 01].

7.03.2 On this, Prof. Manvendra Kishore Das observed that the Centre for Education including distance education and also on teaching quality management should be introduced as a key Department. He suggested that the University may consider opening of a full fledged Centre for Education during the XII Plan Period. He assured that he is willing to provide any assistance in this front needed by the University.

7.03.3 Prof. V.S.Prasad congratulated the Vice-Chancellor for the commendable progress made in the Academic Front and suggested that this tempo should be maintained. He suggested that the affiliated institution should stick to the Academic Calendar of the University. Also, the University can look for more reforms in Examination including orientation of examiners and also in question paper setting. He further added that the University may also attempt to open up an Academic Staff College. While applauding the Chinese language and China Studies programme, he suggested that the University may consider establishing a "Centre on Confucius Studies" in collaboration with the Government of Peoples Republic of China and the Government of India. He further stressed on the establishment of Quality Assurance Mechanism to focus more on quality dimension. He also expressed that the Academic Council also desire to pass a resolution on early acquisition of land at Yangang.

7.03.4 Prof Atul Sarma mentioned that he was deeply impressed with the introduction of semester system even in the colleges which is rather a very difficult task. He mentioned that the University should clearly frame a clear policy on enrolment of students. It was also stated that the University may consider introduction of Resource Management as one of the Departments. The University may also consider introduction of more South East Asian Languages apart from Chinese under the Department of Asian Languages.

7.03.5 Prof S.F.Patil observed that the University may consider introduction of Awards/Appreciations for assessment of the performance of the Teachers in the University as well as in the affiliated colleges. He suggested that the University should constitute a Committee on quality assurance and also make its course innovative so that the students from all over India would be

attracted. He suggested that an advance course on nano-sciences could be also introduced in the integrated course framework.

7.03.6 Prof. Y.D.Prasad observed that the University may consider acquiring the publications of the Members of the Executive and Academic Councils for its library.

7.03.7 Dr. G.S.Yonzone enquired whether the Academic Council also can contribute its role in the acquisition of land at Yangang so that the same can be expedited.

7.03.8 Shri Sanjoy Hazarika reiterated that the Academic Council may also pass a resolution on early acquisition of land at Yangang. He also suggested that the University may consider the recognition of role played by independent groups like NGOs in Sikkim on environment management like 'Plastic Free Sikkim" etc and make use of the same in its studies on Environment. As regards the Department of Peace, Conflict & Management Studies he suggested that the appropriate name shall be 'Department of Peace & Conflict Management Studies". He further suggested that the University should consider the Role of Women in peace process. The University may organise an Annual Lecture/National Seminar on the subject by a prominent woman speaker.

7.03.9 Prof. Anjan Mukherjee mentioned that while starting the BBA-MBA course the University may also consider introduction of Statistics also as part of curriculum.

7.03.10 Prof. Manvendra Kishore Das also mentioned that the University may also consider setting up of Centre[s] for Buddhist/Chinese/Confucius Studies.

7.03.11 Summing up the observations of the Members on various points, the Chairperson replied that;

Sikkim University is facing many challenges in its functioning which are overcome by hard work and dedication. It is incumbent upon the University to set up standards of its own in each of the functional areas. Sikkim University desires to achieve to be one of the best universities in the Country. The University is engaged continuously in setting standards and improving of quality in every sphere. The Chairperson fully agreed that a resolution of the Academic Council on the land issue would be definitely useful in pursuing the case of land with the State Government. As regards establishing of the Centre on Confucius Studies the Chairperson mentioned that this being a sensitive issue and requires clearance from the Government of India. However, it was mentioned that the University is proposing for exchange programmes for Students with the People's Republic of China. The Chairperson requested Prof. Patil to provide his suggestions on integrated courses which the University could consider. As regards the observation on opening of the discipline on statistics, the

Chairperson replied that the same would be considered for inclusion in the XII Plan proposals along with the Department of education preferably from 2012-13. He also mentioned that the idea of constituting a Committee on Quality Management would be taken up in due course.

Similarly, in the case of appointment of paper setters, moderators and evaluators as mentioned under Clause 05.09, the House desired that the same has to be done by the Vice-Chancellor or her/his nominee not less than the rank of a Dean. The House also suggested constitution of a Lapses Committee to look into the lapses by the question paper setters.

7.09.2 At the same time the House also considered the fact, that the said amendment in view of its exigencies was approved by the Executive Council in its last meeting of 3.11.2010.

7.09.3 Therefore, the House resolved that the amendment may remain for the current semester only and for the next semester the House directed that a revised draft amendment may be placed before it considering the suggestions now made by it.
