Chairman welcomed all members of the Executive Council. Thereafter, the agenda items were taken up.

SECTION-1 CONFIRMATION OF THE MINUTES AND ACTION TAKEN REPORT

EC24.1.1: Confirmation of the minutes of the 23rd meeting of the Executive Council held on 31st Oct 2015

The minutes of the 23^{rd} meeting of the Executive Council held on 31.10.2015 was circulated to all the members on 23.11.2015. No comments have been received from any of the members of the Committee. The minutes are placed at **Annexure - I**. The minutes of the meeting may be considered for confirmation.

The minutes of the 23^{rd} meeting the Executive Council held on 31.10.2015 as circulated to all members on 23.11.2015 were confirmed.

EC24.1.2: Action taken report on the minutes of the 23rd meeting of the Executive Council held on 31st Oct 2015

The Action Taken Report on the minutes of the 23rd Meeting of the Executive Council held on 31.10.2015 is placed at **Annexure - II** for consideration of the Committee.

Minute

The secretary read out the action taken report. While confirming the action taken report the members noted that in the constitution of Sikkim University Students' Association there is one contradiction in Article VIII and Article XII regarding eligibility of membership. The members suggested that the constitution of SUSA be reexamined carefully to avoid future complications. Till then the notification of Students' Association may be kept in abeyance.

With this amendment, the Council noted the action taken report.

SECTION - 2 REPORTING ITEMS

EC24.2.1: Agreement between Sikkim University and TATA Consulting Engineers Pvt. Ltd.

Consequent upon the approval of the Executive Council in its 23rd meeting held on 31.10.2015 on selection of TATA Consulting Engineers Pvt. Ltd. as Project Management Consultant for Campus Development Project at Yangang. The agreement has been executed between Sikkim University and TATA Consulting Engineers Pvt. Ltd on 12.02.2016.

Minute

The Council noted the action of the University about signing of the agreement between Sikkim University and TATA Consulting Engineers Pvt. Ltd. as Project Management Consultant for Campus Development Project at Yangang on 12.02.2016.

SECTION-3 RATIFICATION MATTERS

EC23.3.1: Experts in the Selection Committee for the post of Registrar and Librarian

We have carried out the recruitment for the post of Registrar & Librarian based on the advertisement issued in the month of September 2015. The interviews were held on 25.01.2016. As per Statute 18 (2), the Selection Committee has among others the following members.

The post of Registrar:

"Two members of the Executive Council nominated by it. One person not in the service of the University nominated by the Executive Council."

For the post of Librarian:

"Two persons not in the service of the University who have special knowledge of the subject of the Library Science/Library Administration nominated by the Executive Council. One person not in the service of the University nominated by the Executive Council."

In view of the above clauses, Selection Committees were constituted by the Vice-Chancellor. The following experts were invited as members of the Selection Committees for the post of Registrar and Librarian:

The Council discussed the agenda item and ratified the action taken by the Vice Chancellor in nominating experts in the Selection Committee for the post of Registrar and Librarian.

EC24.3.2: Resignation and Withdrawal of Resignation of Prof. Irshad Gulam Ahmed from the post of Professor in the Department of English

Prof. Irshad Ghulam Ahmed joined the University as Professor in the Department of English on 21.05.2014 on lien. His service at the University was yet to be confirmed. In the letter dated 10.12.2015 Prof. Irshad Gulam Ahmed tendered his resignation from the post of Professor in the Department of English and requested to be released from 15.12.2015 (A/N) in order to join his previous organization, Department of Higher Education, Darjeeling Government College, Government of West Bengal within the period of his lien.

The Vice-Chancellor accepted his resignation and relieved him from the services of the University w.e.f. 15.12.2015 (A/N).

Prof. Irshad Gulam Ahmed vide letter dated 04.01.2016 submitted a request to withdraw his resignation dated 10.12.2015 from the post of Professor and requested to allow him to revert to the post w.e.f. 01.02.2016. The Vice-Chancellor accepted his request and allowed Prof. Irshad Gulam Ahmed to revert to the post of Professor in the Department of English w.e.f. 01.02.2016.

Acceptance of resignation/withdrawal of resignation in respect of Prof. Irshad Gulam Ahmed by the Vice-Chancellor is submitted for ratification by the Executive Council.

Minute

While discussing the item the Chairman asked Prof I.G.Ahmed to leave the meeting hall since the matter was related to him. The Council discussed the agenda item and ratified the action taken by the Vice- Chancellor in acceptance of resignation/withdrawal of resignation in respect of Prof. Irshad Gulam Ahmed, Department of English.

EC24.3.3: Revision of date of relieving of Dr. Teiborlang T. Kharsyntiew

The Executive Council in its 23rd meeting held on 31.10.2015 accepted the request of Dr. Teiborlang T. Kharsyntiew, Assistant Professor, Department of

International Relations to be relieved on lien w.e.f. 03.01.2016 to join as Assistant Professor in Jawaharlal Nehru University, New Delhi.

Dr. Teiborlang T. Kharsyntiew in his letter dated 02.12.2015 submitted his request to be relieved on lien w.e.f. 31.01.2016 stating that he is awaiting final submissions of few M.Phil students whom he is supervising and therefore requested for revision in the date of his release.

In view of the stated reasons, the Vice-Chancellor accepted his request to be relieved w.e.f. 31.01.2016.

Minute

The Council discussed the agenda item and ratified the action taken by the Vice-Chancellor in relieving Dr Teiborlang T. Kharsyntiew with effect from 31.01.2016 (A/N) instead of 03.01.2016.

EC24.3.4: Application of Ms. Jasmine Yimchunger for extension of Study Leave

The Executive Council in its 23rd meeting held on 31.10.2015 granted Study Leave to Ms. Jasmine Yimchunger, Assistant Professor, Department of Mass Communications for a period from 01.07.2015 – 16.12.2015. Ms. Jasmine Yimchunger requested for extension of Study Leave upto 31.07.2016 vide letter dated 30.11.2015.

On the recommendation of the Department, the Vice-Chancellor accepted the extension of Study Leave for a period upto 30.06.2016 subject to ratification by the Executive Council.

The matter is submitted for ratification by the Executive Council

Minute

The Council discussed the agenda item and ratified the action taken by the Vice-Chancellor in extending the study leave of Ms Jasmine Yimchunger up to 30.06.2016.

EC24.3.5: Extra Ordinary Leave of Dr. Sudarsan Tamang

The Executive Council in its 20th meeting held on 28.06.2014 approved grant of Extra Ordinary leave to Dr. Sudarsan Tamang for a period of two years w.e.f. 17.11.2014 to 16.11.2016. However, Dr. Sudarsan Tamang reported back on duty after availing Extra Ordinary Leave for about 1 year on 08.12.2015, i.e. prior to the expiry of his leave. The Vice-Chancellor accepted his joining on 08.12.2015 (F/N).

The matter is reported to the Executive Council for its ratification.

The Council discussed the agenda item and ratified the action taken by the Vice-Chancellor to allow Dr Sudarsan Tamang, Assistant Professor, Department of Chemistry to join on 08.12.2015 which is before completion of his two years of EOL from 17.11.2014 to 16.11.2016.

SECTION-4 MATTER FOR CONSIDERAITON AND APPROVAL

EC24.4.1: Appointment of Registrar & Librarian of the University

The University advertised for the post of Registrar & Librarian vide advertisement No.SU/2013/REG-03/NTSR-2013/2394 dated 25th September, 2015 the interviews for both the posts were held on 25.01.2016. Against the advertisement, number of applications were received. 12 candidates were shortlisted for the post of Registrar and three were shortlisted against the post of Librarian. The proceedings of the Selection Committees are placed for approval by the Executive Council.

Minute

The Vice-Chancellor informed all the members that the interviews for the post of Registrar and Librarian were held on 25.01.2016. He also informed that 12 candidates were shortlisted for the post of Registrar and 3 candidates were shortlisted for the post of Librarian. Thereafter, Selection Committee proceedings were opened and the following persons as recommended by the selection Committee were approved:

For the post of Registrar

i) Sri T.K.Kaul Selected ii) Sri U.S.Tolia Waitlisted

For the post of Librarian no candidate was found suitable.

While discussing the agenda item the Vice-Chancellor informed that the term of Professor A.S.Chandel who was working as Librarian (On contract) in Sikkim University was getting over on 31.03.2016. Since selection process of Librarian has to be made afresh and the process involved may take another 6 months the Council decided to extend the term of appointment of Prof. A.S.Chandel by another 6 months with effect from 01.04.2016.

EC24.4.2: Re-designation of Dr. Suresh Kumar Gurung as Joint Registrar

Dr. Suresh Kumar Gurung joined the University on 15.11.2010 as Deputy Registrar in the Pay Band of ₹ 15,600-39,100 with Grade Pay of ₹ 7,600/-. He has completed 5 years of continuous service on 14.11.2015.

The directives of MHRD & UGC vide letter dated 31.12.2008 and 01.10.2014 respectively, states the following:

"(i)Deputy Registrar, in the pay sale of ₹ 15600-39100 with Grade Pay of ₹ 7600, on completion of 5 years is eligible to move to the Pay Band of Rs. 37400-67000 with a Grade pay of ₹ 8700. MHRD has now approved the proposal to re-designate such Deputy Registrars as Joint Registrar, with the stipulation that the post will revert as Deputy Registrar when it falls vacant."

In view of the above directives, we may consider re-designation of Dr. Suresh Kumar Gurung as Joint Registrar in the Pay Band of ₹ 37400-67000 with a Grade Pay of ₹ 8700/- w.e.f. 15.11.2015 with DNI on 01.07.2016, with the stipulation that the post will revert as Deputy Registrar when it falls vacant.

Submitted for consideration and approval of the Executive Council.

Minute

While discussing the item no 24.4.2 and 24.2.3 the Officiating Registrar took permission from the Chair to leave the EC meeting since the matter involved himself and his colleague of same cadre. The Chairman granted him permission to leave the meeting hall.

The council discussed the matter and accorded approval to re-designate Dr. S.K.Gurung as Joint Registrar in the pay band of \gtrless 37400-67000 with GP \gtrless 8700 with effect from 15.11.2015 with the stipulation that the post will revert as Deputy Registrar when it falls vacant. His DNI is 01.07.2016.

EC24.4.3: Re-designation of Shri Chandan Talukdar as Joint Registrar

Shri Chandan Talukdar joined the University on 29.11.2010 as Deputy Registrar in the Pay Band of \gtrless 15,600-39,100 with Grade Pay of \gtrless 7,600/-. He has completed 5 years of continuous service on 28.11.2015. The directives of MHRD & UGC vide letter dated 31.12.2008 and 01.10.2014 respectively, states the following: "(i)Deputy Registrar, in the pay sale of \mathbf{E} 15600-39100 with Grade Pay of \mathbf{E} 7600, on completion of 5 years is eligible to move to the 5 Pay Band of Rs. 37400-67000 with a Grade pay of \mathbf{E} 8700. MHRD has now approved the proposal to re-designate such Deputy Registrars as Joint Registrar, with the stipulation that the post will revert as Deputy Registrar when it falls vacant."

In view of the above Shri Chandan Talukdar is eligible for re-designation as Joint Registrar w.e.f. 28.11.2015.

However, Shri Chandan Talukdar who is senior as per seniority to Dr. Suresh Kumar Gurung is eligible for upgradation w.e.f. 15.11.2015. Therefore, the case of Shri Chandan Talukdar may be viewed under FR-22C now FR22(I)(a)(1):

"on removal of anomaly by stepping up of pay of senior on promotion drawing less pay than his junior. The Government servant drawing a lower scale of pay in the post than another Government servant, junior to him in the lower grade and promoted on or appointed subsequently to another identical post, the senior officer in the higher post should be stepped up to a figure equal to the pay as fixed for the junior officer in the higher post. The stepping up should be done with the effect from the date of promotion or appointment of junior officer and will be subject to the following conditions, namely:

Both the junior and senior officer should belong to the same cadre and the posts in which they have been promoted or appointed should be identical and in the same cadre, The scale of pay of the lower and higher posts in which they are entitled to draw pay should be identical"

Under the above provision Shri Chandan Talukdar may be re-designated as Joint Registrar in the Pay Band of ₹ 37400-67000 with a Grade pay of ₹8700/- w.e.f. 15.11.2015 with DNI on 01.07.2016 Submitted for consideration and approval of the Executive Council.

Minute

The Council discussed the matter and accorded approval to re-designate Sri Chandan Talukdar as Joint Registrar in the pay band of ₹37400-67000 with GP ₹8700 with effect from 15.11.2015 and DNI as 01.07.2016 with the stipulation that the post will revert as Deputy Registrar when it falls vacant.

While approving the matter the council also maintained that the inter-se seniority of Sri Chandan Talukdar and Dr. S.K.Gurung will continue as Joint Registrar.

EC24.4.5: Extraordinary leave of Prof. Sameera Maiti

Prof. Sameera Maiti has requested for extraordinary leave for a period with effect from 01.02.2016 to 31.07.2016 stating medical reason. She has informed that she has been advised for immediate Chemotherapy for her treatment which is not possible in Gangtok.

Under the provisions of extraordinary leave (8)(ii) "this leave can be allowed only to a teacher who has been confirmed in the post held by him and has served the University for a period of at least three years of service in the University."

In view of above, Prof. Sameera Maiti is not eligible for extraordinary leave however, under special circumstances (medical conditions) as stated by her we may under the ordinance OB-3 (8)(viii) "the authority empowered to grant leave may commute retrospectively period of absence without leave into extraordinary leave" consider her request.

Further, since she has earned leave of seven days in her credit and extraordinary leave can only be availed when no other leave is admissible, her extraordinary leave may be considered for a period with effect from 08.02.2016 to 30.06.2016 and not upto 31.07.2016 keeping in mind the next semester academic programme.

Since, there has been no adverse remarks and in view of the satisfactory performance report, we may lift the probation and confirm Prof. Irshad Gulam Ahmed in the services of the University with effect from the day following the date of completion of probation period.

While discussing the item the Chairman asked Prof I.G.Ahmed to leave the meeting hall since the matter was related to him. The council then discussed the agenda item and accorded approval to confirm the services of the University with effect from 22.05.2015.

EC24.5.2: Report of the Committee constituted for review of existing Recruitment & Promotion Rules (Non-Teaching) and submission of the revised Recruitment Rules (Non-Teaching)

The University was in receipt of various directions from the UGC regarding Recruitment and Promotion rules which is as under:

- F. No. 16-40/2015(CU), dated 14.01.2016, subject: Minutes of the meeting of the committee of Secretaries held on 14.09.2015 in Rashrapati Bhawan, New Delhi, regarding "Discontinuation of Interview for various Junior Posts in Govt. of India",
- (2) F. No. 69-4/2012(CU), dated 14.08.2015, Subject: regarding Revision of guidelines for framing/amendment/relaxation of Recruitment Rules,
- (3) F.No. 3-2/2012 (JCRC), dated 28.10.2015, Subject: regarding Pay Scale of Assistant Registrar through promotion

Following this, there was a representation from the non-teaching staff requesting for review of the existing Recruitment and Promotion Rules 2014. In view of the above directives of the UGC and the representation of the nonteaching staff the Vice-Chancellor constituted a Committee with the following members to review the existing Recruitment and Promotion Rules (nonteaching), 2014 and to frame the Recruitment and Promotion Rules inconformity with other Central Universities and latest UGC guidelines on Recruitment Rules.

- 1. Dr. Biran Das, Registrar, Tezpur University, Assam, External Expert
- 2. Shri Chandan Talukdar, Registrar (Officiating), Member
- 3. CA. P.K. Singh, Finance Officer, Member
- 4. Prof. A.S. Chandel, Librarian, Member
- 5. Ms. Grace Dechen Chankapa, Assistant Registrar (Estt.), Convenor

The committee has submitted its detailed report along with the revised Recruitment and Promotion Rules, Non-Teaching, 2016 confirming strict compliance of the UGC guidelines.

The report of the committee along with the revised Recruitment and Promotion Rules is submitted for approval of the Executive Council

The Vice-chancellor briefed the members about the purpose of the Constitution of the Committee, which was to review the existing Recruitment and Promotion Rules 2014 and the need for review of the same. He also informed that one external expert, Dr Biren Das, Registrar Tezpur University was also part of the committee. The council discussed the matter and suggested that interview for Group B Gazetted post may be held. The Vice-chancellor also informed that probation period for various post may be made as per Ordinance of the University which had the approval of MHRD vide letter dated 2.2.2016.

The Council then approved the report of the Committee constituted to review the Recruitment Rules and approved the Recruitment & Promotion Rules 2016 in place of Recruitment & promotion Rule 2014.

Annexure - III

EC24.5.3: Exemption to travel by Private Airlines

As per the Office Memorandum (F No. 19024/1/2009-E-IV Dt. 13-07-2009) issued by Ministry of Finance, Government of India, in all cases of air travel, where the Government of India bears the cost of air passage, the officials concerned shall travel only by Air India. For travels to stations not connected by Air India, the officials may travel by Air India to the hub/point closest to their eventual destination, beyond which they may utilize the services of another airline which should also preferably be an alliance partner of Air India. In all cases of deviation from these orders because of operational or other reasons or on account of non-availability, individual cases has to be referred to the Ministry of Civil Aviation for relaxation. In the case of LTC, air travel should be by Air India only.

As per clause 2.4 (iv) of OM (F.No.7 (1)/E.Cord./2014 dated 29.10.2014 issued by Ministry of Finance ,GOI on the subject Expenditure Management-Economy Measures and Rationalization of Expenditure in all cases of air travel the lowest air fare tickets available for entitled class are to be purchased/procured. No companion free ticket on domestic/international travel is to be availed of.

In Sikkim University we are inviting experts/selection committee members/examiners/resources person/members of statutory bodies to attend various meetings, seminar/workshop and examination related duties. Moreover its officers and teachers are also required to go to other places for attending meetings, seminar and workshop etc. It is not always possible to travel by Air India from Bagdogra (WB) which is the nearest airport of Sikkim and 125 KM from Gangtok. Moreover there is only one Air India flight from Bagdogra to New Delhi and back.

In view of this it is proposed to accord permission to travel by private airlines to the eligible members of University community including members of various statutory bodies /examiners/resource persons/experts etc. to save time, cost etc. However this relaxation will not be applicable in LTC cases.

Minute

The Council discussed the matter and felt that considering the connectivity of Sikkim which is a state in northeast region, with rest of the Country and its road condition to reach its nearest airport (Bagdogra Airport) which is 125-130 KM from Gangtok, time factor, cost factor, non-availability of sufficient number of Air India Flight from Bagdogra Airport to rest of the country it is appropriate to accord approval to the proposal of the University to travel by any airlines to its eligible members. However attempt should be made to travel by Air India whenever possible.

The Council further approved the proposal of the University to allow travel only by Air India in LTC related cases except for exempted sectors.

EC.24.5.4: Nomination to the Governing Body/Advisory Committee of affiliated Colleges

The Executive Council in the last meeting held on 31.10.2015 approved the Ordinance on Governing Body and Advisory Committee. In terms of the said Ordinance, the Governing Body/Advisory Committee of each College shall consist of two teachers of the University, not below the rank of Associate Professor, to be nominated by the Executive Council amongst others.

In view of the commencement of the Odd Semesters in all the colleges for February 2016 and the urgency involved in constituting the Governing Body/ Advisory Committee in all affiliated Colleges, the Vice-Chancellor nominated the teachers of the University to the respective Governing Body/Advisory Committee of the Colleges. The list of the teachers nominated is enclosed herewith.

This action of the Vice-Chancellor may be ratified by the Executive Council.

The Council approved nomination of members to Governing Body/ Advisory Committee of various colleges affiliated to Sikkim University as per <u>Annexure IV</u>

EC.24.5.5: Constitution of Governing Body of affiliated colleges

Section 31 (1) (i) of the Statutes of the University mentions the following provision.

" Every such College or Institution shall have a regularly constituted Governing Body, consisting of not more than fifteen persons approved by the Executive Council......"

In pursuance of the above provision and the Ordinance on Governing Body/Advisory Committee, three affiliated private Colleges of the University have constituted their respective Governing Bodies. The said Colleges are

- i. Harkamaya College of Education, 6th Mile, Tadong, Gangtok
- ii. Damber Singh College, 6th Mile, Tadong, Gangtok
- iii. Himalayan Pharmacy Institute, Majhitar, Rangpo

The composition of the respective Governing Body of the above Colleges are enclosed herewith for approval of the Executive Council.

Further two affiliated Colleges maintained by the Govt. of Sikkim have constituted their respective Advisory Committee. The Colleges are

- i. Sikkim Government College, Tadong, Gangtok
- ii. Sikkim Government Law College, Burtuk, Gangtok

The composition of the respective Advisory Committee of the above Colleges are enclosed herewith for information of the Executive Council.

Minute

The Council approved the Constitution of Governing Body of various colleges affiliated to Sikkim University as per <u>Annexure- V</u>
