MINUTES OF 38th MEETING OF THE FINANCE COMMITTEE HELD AT INDIAN NATIONAL SCIENCE ACADEMY(INSA), NEW DELHI, 110002 ON 6TH MARCH 2024 FROM 11:30 A.M. ONWARDS

Since all the members of the Finance Committee were present, it was hereby confirmed that a quorum, was present to conduct the meeting effectively.

The Chairman called the meeting to order by 11.30 AM as per schedule.

At the outset, the Chairman extends welcome message to all the members present in the 38th meeting of the Finance Committee organized at INSA, New Delhi. He thanked each member for their commitment and their dedication for financial well being of the University for a sustainable growth of the University. He also emphasized that decisions taken today will have a direct impact on the operation/growth/success of our University and urged all the members to actively participate with their perspectives.

Before the Agenda points were taken up, the Chairman accentuated briefly the most important activities like ongoing construction works at permanent campus after flashflood situation in Sikkim, developing basic infrastructure in the completed three buildings for further shifting of departments from May 2024 onwards and fund flows. He further enunciated strategies to overcome various obstacles due to various topographical disadvantages to maintain smooth progress in the development and function of the permanent campus. The gist of the opening remarks by the Chairman is mentioned below:

1. Lepcha, Limbu & Bhutia Departments have already been shifted to the permanent campus w.e.f 28.11.2022 and operating smoothly there.

2. Severe Flash flood occurred in the month of October 2023 which disrupted the entire transport system to the Permanent Campus

3. Only Rs.7 crores was released for the construction work till January 2024 during the FY 2023-24 resulting in difficulty to oblige the contractor's bills. However, Rs.60 crore more has been released in the month of February 2024 which has helped to finance the project for which the Chairman expressed thanks to the UGC & MoE for the release.

4. Considering the need of the University, additional Rs,2 crore has also been allocated under Capital Head for developing basic infrastructure like partitions, prefabricated bathrooms/toilets, Prefabricated roof tops, safety railings and temporary STP for shifting few more departments in the month of May 2024

5. The Chairman intimated to the Committee that University has now taken over three completed Buildings from the Contractor i.e Administrative Building, Library Building and

Faculty Building

6. This has been officially notified to shift another four departments in the first week of May 2024. These departments are Nepali, International Relations, Political Science and

Geography

7. These three taken over buildings (Administrative, Faculty & Library) and the Guest House available in the permanent Campus at Yangang will be used as follows to accommodate students, faculty & staff by providing basic infrastructures:

a. Faculty Building will be used as Girls' Hostel for accommodation of around 170 students by providing extra safety railings, temporary STP, Prefab bathroom/toilets,

Kitchen & Dining space etc.

b. Library Building will be used as a Library itself along with 12 classrooms and rooms for faculty, staff etc. along with a Departmental store. Some more prefab toilets will also be added to the complex

Administrative Building Ground floor will be used for Administrative Office, Store

Room and Health Center etc.

d. Guest house will be used for Boys Hostel with 50 seats by making prefabricated

roof top and other necessary facilities

8. The University is also following up with the Govt. of Sikkim to allow Sikkim University to transport materials through the barrage adjacent to the collapsed bridge on flash flood. In the meanwhile, the contractor is transporting materials in a longer route the Permanent Campus

9. It was also informed the house that despite of all the challenges, it is his commitment to go on shifting the departments in a phased manner to the permanent campus by vacating the rented buildings occupied and will take all necessary efforts to ensure timely completion

of the Package- II construction and make the Campus fully operational.

The members on record, expressed their sincere appreciation for the Hon'ble Vice-Chancellor for his leadership and commitment towards the completion of the permanent campus and guidance to the team headed by him for the endeavor made for gradual shifting of the Departments and continuation of the construction activities notwithstanding the obstacles like natural calamities like devastating flash flood, topographical & climatic disadvantages.

The members expressed their good wishes to the Chairman of the Finance Committee, for his dedication with advice that the same spirit to continue till full operationalization of the permanent campus within the stipulated period by maintaining cohesion in the team, all the departments and the whole University to make the permanent campus fully operational.

Then Chairman requested the Finance Officer & Secretary to present the Agenda Items of the Finance Committee. Then the agendas were taken up by the Secretary, along with the comments received from IFD, Central University Bureau & UGC regarding each agenda item.

The Committee further noted that due to recent flash flood situation in Sikkim on 03.10.2023, the transport facility to the Permanent campus has been disrupted. The Contractor has stopped the work initially till the transportation facility is restored.

However, due to persistence request by the Hon'ble VC to expedite the work in view of the shifting of Departments, the Contractor has agreed to transport construction materials through another longer route till arrangements are made with the State Government to allow vehicles of the Contractor in the adjacent barrage of the damaged bridge. The University is constantly following up with the State Government for permission to use the Barrage to carry construction materials for the Campus.

The Committee also noted the physical/financial status as enunciated by the Hon'ble VC in the opening remarks.

- 38.2.5 Pending issues of the University with the UGC/Ministry:
- a) Request for release of Grant under EWS for payment to the Contractor for construction of Hostels at the permanent campus at Yangang.

The Committee noted the pending issues with the UGC/Ministry and advised to follow up the matter with the concerned.

For EWS Grant, it is advised to submit a fresh DPR for the total amount of Rs.21.70 crore.

<u>SECTION – 4</u> <u>MATTERS FOR CONSIDERATION AND APPROVAL</u>

38.4.1 Proposal for development of Infrastructure in the Permanent Campus out of the approved cumulative unspent balance of Rs. 344.40 Lakhs under Capital (OH-35) till the F.Y. 2024-25:

The Finance Committee in its 37th meeting held on 23.11.2023 approved the extension for utilization of the cumulative unspent balance under Campus Development Grant for its utilization till the F.Y. 2024-25 with an advice to utilize the Grant under the same Head only.

Considering the fact that the University has strong requirement of fund for early shifting of Departments to the Permanent Campus at Yangang for development of infrastructure facilities for providing basic infrastructure to the Faculty, Staff & Students which are not covered under Package-I & II constructions, the Committee approved the utilization of unspent balance of the Grant for the following works as proposed by following due procurement procedures on receipt of approval from the Ministry:
