Such changes are likely to continue in near future. Library and Information Science is of the subjects which are influenced most by new technology. 
# Serial Management

Library provides access to the serial holdings of the library on two platforms; Library software and DSpace (Digital Library Management Software). The list of the journals appears as shown below which provides direct access to the issues and their content. The holding list of journals is also given in Digital Repository with their content pages searchable under every word given in table of contents. Library subscribes 80 on-line journals including IEEE Xplore, Indiastat, Economic Outlook (CMIE) and PsycArticles in addition of 160 printed journals. Library also has access to UGC-Infonet and DelCon consortium which provides access and full-text download facilities to thousands of e-resources. # **Digital Repository**

Library took the initiative of developing digital repository about a year age. It aims at digitizing as many resources as possible based upon their usefulness to the faculty and students of the University. It has so far archived following resources:

- ◆ Content Pages of Journals and Annuals: The contents pages of all journals and other serials like annual reviews and advances in the subject concerned available in the library have been digitized and archived with the facility of free-text searching of their contents.
- Publications of Faculty: Articles and books published by faculty members are being digitized and archived.
- ◆ Literature on North-East India and Himalayan Studies: Library is archiving all literature published on North-East India and Eastern Himalaya with special emphasis on literature published on Sikkim. The policy of digitization is not to digitize whole books due to copyright restriction but limit it to cover pages, contents, introduction and one or two chapters so that users could know full contents of the documents and their relevance to them.
- ◆ Theses: All M. Phil theses submitted to Sikkim University have been digitized and archived.
- ◆ E-book Collection: Library is engaged in developing e-book collection. So far it is engaged in re- packaging of open access resources which are being placed in the digital repository.

# Competency- based Education for Knowledge Aspirants in Present Scenario

Recently, the terms competency-based education or competency-based learning have become more widely used by (i) online schools or companies selling online learning programs and (ii) colleges and universities, particularly those offering online degree programs. Competency-based education is different from traditional education in that it breaks from the credit hour. today's prevailing measure of student progress. It refers to systems of instruction, assessment, grading, and academic reporting that are based on students demonstrating that they have learned the knowledge and skills they are expected to learn as they progress through their education. It offers returning adult learners a real opportunity to earn a college degree while balancing commitments to work and family, this innovative model is not for everyone. When schools transition to a competency-based system, it can entail significant changes in how a school operates and how it teaches students, affecting everything from the school's educational philosophy and culture to its methods of instruction, testing, grading, reporting, promotion, and graduation. Many for-profit virtual schools and online degree programs, for example, have been accused of offering low-quality educational experiences to students, exploiting students or public programs, and using the popularity of concepts such as "competency-based education" to promote programs of dubious

In today's traditional higher education model, students must accumulate a set number of credit hoursusually 120 to earn a bachelor's

degree. Students earn the same number of credits regardless of the grade they receive from their instructors, provided the grade is passing. Competency-based education turns the traditional model on its head. Instead of awarding credits based on how much time students spend learning, this model awards credits based on whether students can prove they have mastered competenciesthe skills, abilities, and knowledge required in an area of study. The general goal of competency-based learning is to ensure that students are acquiring the knowledge and skills that are deemed to be essential to success in school, higher education, careers, and adult life. Competency-based educational models are poised to make a significant impact amid the increasing innovations and improvements going on in higher education. The CBE models are adultfriendly and cost effective.

Competency-based learning attempts to break away from the regularly scheduled classroom model, where students study the same subject matter at the same speed in a cohort of fellow students. The basic premise behind competency-based education is to achieve the outcome. Competency-Based Education and Training is an approach to teaching and learning more often used in learning concrete skills than abstract learning. It differs from other non-related approaches in that the unit of learning is extremely fine grained. Schools may also use different methods of instruction and assessment to determine whether students have achieved competency, including strategies such as demonstrations of learning, learning

pathways, personal learning plans, portfolios, rubrics, and capstone projects, to name just a few. CBE models encourage building courses, programs, and degrees based on what knowledge and skills a student can successfully demonstrate through reliable and valid measurements. I think this is a good time to explore the benefits of a competencybased approach to training and assessment. Here are six benefits both for the employer and the employee like cost effectiveness, efficiency, increased productivity, improved profitability, reduced risk and increased customer satisfaction. Being aware of these benefits, you should seriously be considering (if not actually implementing) a competency-based approach to training, development, and assessment in the near future.

One positive aspect of Competency-Based Education is the promotion of individualized learning. A model such as CBE that promotes individualized learning while accommodating multiple learning styles and levels of engagement is certainly exciting. Another main attraction for adult students in choosing a CBE educational model is the potential to "get credit" for life and work experience. In more traditional models, everyone generally starts at the beginning of a course and works through each activity to the end before having the opportunity to take the final exam. The most effective CBE models do not rely on a single type of assessment for a course; rather each course has at least two measurements: an objective assessment and a performance-based assessment. The most effective models are also fairly keen to disclose to the student, as much as is Dr. Anju Verma

responsibly possible, the standards against which they will be measured and the formats of the tests themselves. From an administrative perspective a CBE educational model opens doors to innovation in course and assessment delivery, many of which have cost-effective measures built in. The concerns over rigor and quality control are real, but are starting to be addressed in functional and research-based ways. It's an exciting time to be part of the innovation and creativity that is jumpstarting the re-structuring of higher education.


Competency-based education is a relatively new approach to learning design which is proving increasingly popular with employers and suits certain kinds of learners such as adult learners seeking to reskill or searching for mid-level jobs requiring relatively easily identifiable skills. It does not suit though all kinds of learners and may be limited in developing the higher level, more abstract knowledge and skills requiring creativity, high-level problem-solving and decision-making and critical thinking. A feature of most competency-based programs is a partnership between employers and educators in identifying the competencies required, at least at a high level. Competency based training is an approach to vocational education and training that places emphasis on what a person can do in the workplace as a result of completing a program of training or based on workplace experience and learning.


